1. The data controller

2. Categories of personal data

This information is not collected to be associated with identified interested parties, but which by their very nature could, through the processing and the association with other data held by third parties, allow users to be identified. This category of data includes IP addresses or domain names of the computers used by users connecting to the website, URL and URI of the requested resources, the time of the request, the size of the file obtained in response and other parameters related to the operating system and the IT environment of the user. These data are used for the sole purpose of obtaining anonymous statistical information on the use of the website and to check its correct functioning and are deleted immediately after processing.

-Cookies

Our website also uses some cookies. Cookies are small text files that the websites visited by the user (but also other websites or webserver) send and record on your computer to be then vice versa retransmitted to the same websites (or webserver), at the subsequent visit of those, sending thus information. Cookies are now essential tools as they allow modern websites to work best, allowing maximum customization, interaction and fluency in navigation. They can also be used to monitor user navigations and then send advertising messages in line with those.

3. Finality of the treatment and conferral

Your personal data are collected for the following purposes:

A) to provide a service, to respond to a request or to execute a contract (legal basis: Article 6 letter b GDPR-execution of the contract)

B) to fulfill the legal obligations to which the data controller is bound (legal basis: Art.6, lett. GDPR - fulfillment of legal obligations);

C) if necessary, to ascertain and exercise the rights of the controller in court (legal basis of processing: Article 6, letter f GDPR - legitimate interest);

Your personal data are also collected, only prior to and your specific and distinct consent, for the following purposes:

D) to send you via email newsletters, commercial communications and / or advertising material on products or services offered by the Controller.

The provision of data is strictly necessary for the purposes of carrying out the activities referred to in point n.3.A. Any refusal by the interested party to provide the data implies the impossibility of proceeding with the provision of the service, establishment and / or execution of the contract itself. The provision of data for the purposes referred to in point 3D), however, is optional and their failure to provide will result in the inability to send newsletters, commercial communications and / or advertising material on products or services offered by the controller.

4. Mode of treatment and conservation

The processing can be performed with or without the aid of electronic or automated tools, in compliance with the provisions of the GDPR 2016/679 in order to guarantee the security and confidentiality of the data. Please note that in compliance with the principles of lawfulness, purpose limitation and data minimization, pursuant to Article 5 of GDPR 2016/679, your personal data will be retained for the period of time necessary to meet the purposes indicated above and for the

5. Scope of communication and dissemination

The data may be disclosed to public bodies, judicial authorities as well as to all subjects to whom the communication is mandatory for the fulfillment of legal obligations.

6. Data transfer in EU and non-EU countries

Personal data will not be transferred either to Member States of the European Union or to third countries outside the European Union. In the case of data transfer in the European Union and non-European countries, the instructions referred to in Article 44 and GDPR 2016/679 will be followed.

7. Rights of the interested party

We inform you of your rights, pursuant to articles 15 to 22 of EU Regulation n. 2016/679, or the right to:

- a) access to personal data (request confirmation of the existence or not of personal data and obtain information about the purposes of the processing, the categories of personal data, the recipients or the categories of recipients to whom the personal data have been or will be disclosed and, when possible, the period of conservation);
- b) obtain the correction, the limitation and the cancellation of the data;
- c) obtain data portability;
- d) oppose the processing at any time and an automated decision-making process concerning individuals, including profiling:
- e) withdraw the consent at any time;
- f) propose a complaint to a supervisory authority.
